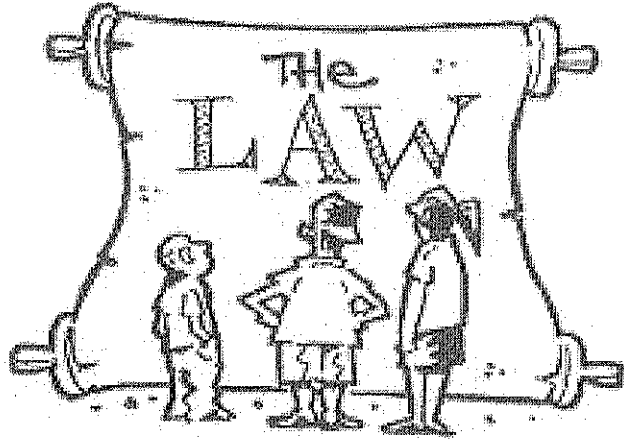

2012 was a big year for the Law Library.

New programs that started in 2011 - our partnership with Legal Assistance of Olmsted County to provide legal information clinics, and our outreach service to Olmsted County pre-trial detainees - took hold and grew nicely, showing that there were indeed stakeholder groups that needed to be served. In addition, a new program was added beginning in May 2012, a monthly free Continuing Legal Education class for local judges, law clerks and attorneys.

Efforts were also made to reach out to other populations, with the Law Librarian guest-lecturing in several classes for the Minnesota School of Business paralegal and criminal justice programs, and manning a table for 6 hours in September to spread the "Law Library" word to seniors through the annual Generations Expo at the Rochester Civil Center.

Members of the 2012 **Law Library Board of Trustees (Jerry Perry, Darren Burchill, Judge Joseph Chase, Judge Kevin Lund, Janet Krueger and Judy Ohly)** deserve special recognition for freely giving extra time to many special projects that were completed over the past year, including a review and updating of the Law Library Board's Bylaws, and approval of new "Mission" and "Vision and Goals" Statements, as well as several other operating policies and procedures.

And, at the last meeting of the Board in December 2012, the Board approved several new projects and goals for 2013, guaranteeing that the Law Library will continue to move forward in the new year. But that is for the 2013 Annual Report. For now, please enjoy the 2012 Annual Report.

Law Library Partnership with Legal Assistance of Olmsted County (LAOC)

In September of 2011, the Law Library entered into an agreement with Legal Assistance of Olmsted County (LAOC) to provide free legal clinics to self-representing litigants who either lived in Olmsted County, or who had their cases filed and being heard in Olmsted County.
